Your comments will be reviewed and, if required, amendments made to the Plan; then there will be a further 6 week consultation undertaken by Durham County Council, followed by an examination by an Independent Inspector and finally a referendum for the whole of Great Aycliffe Parish later this year which will be a simple 'YES' or 'NO' vote.

What have we done so far?

- **1.** A town wide survey and consultations at over 40 events to find out what was Important to you.
- **2.** Prioritised those comments (over 10,000) which gave the following six key topic areas:-
- * Environment

- * Housing
- * Retail, Leisure and Economy
- * Aycliffe Village
- * Sustainability and Climate Change
- * Transport and Access
- **3.** Set up a number of 'Thematic Groups' and a 'Steering Group' to undertake research and investigate options and proposals.
- **4.** We undertook a second town wide and electronic survey to find out if there was support for our proposals. All of which received overwhelming support.
- **5.** We gained funding and undertook a 'Soft Market Testing of Retailers' and 'Heritage and Character Assessment' to better understand two of the most important areas for our residents protecting our green spaces and improving retail.
- **6.** There was no interest from retailers to invest in Newton Aycliffe but there was evidence to justify protecting our green spaces.
- **7.** Following further investigation and research we have developed 31 policies for the Parish of Great Aycliffe to protect our uniqueness.

This Pre-Submission consultation stage is your chance to tell us your view on the Plan and our policies.
